  - a. 100-Day Challenge Update
    - L. Hinojosa – Challenge ended late November/early December; 14 families housed, 89 referrals have been made; 41 Tulare County and 19 Kings County vouchers have been closed due to expiring; Barriers to successfully housing 100: Lack of available affordable housing, Landlord expectations are stricter than PEH can meet.
  - b. PIT Update
    - L. Fisher – Slight drop in number of volunteers, but still over 100; Count closed this morning, numbers will be available before the April HUD deadline; Report out this summer; Safety precautions used for volunteers; Survey was given with incentives; Numbers may be skewed by: Recent dispersal of PEH across counties, PEH living in cars, and some declined to participate.
  - c. Funding Update
    - M. Perez—KTHA applied for Cal-AIM Community Supports funding; will hire staff if selected; Emergency Solutions Grant (ESG) awards will be announced by end of February; HHAP-3, Once NOFA is released, RFP will be announced; Encampment Resolution Funding will be used to address the PEH population along the railroad tracks in Tulare, KTHA will hire additional HN to assist, award will be announced in March; Working toward a resolution regarding Stardust in Kings County to facilitate the transition to PSH.
