  - a. City of Tulare Shelter Update Terry Sayer: Shelter has been approved and will begin first phase in July 2022. Cooling/warming/sanitation. County beds will also be available. The three phases of this project are in the link below. <u>https://youtu.be/XHTFUMERM8Q?t=6501</u>
  - b. Community Snapshot Dashboard Vote Lucia Orozco: Adding full project names to dashboard by October 2023. Dashboard is public to the community and provides information such as Data Quality, Inflow vs Outflow by month, Racial Equity, Demographics.   - c. HMIS Update Lucia Orozco: Site visits are currently underway at program facilities. Three projects have been added to HMIS. Tule Tribe Outreach and Shelter and City of Tulare Encampment Resolution.
  - d. CES Update Leticia Hinojosa: CES Referrals from 7/2021 4/30/22. 241 total referrals, 62 days referred, 31 housed.
  - Racial Equity Project Update Leticia Hinojosa: Program Overview from February training. Outreach staff to engage in 15–20-minute discussion regarding racial equity at least twice a year. Connecting and learning from the tribal community and reviewing our CES to identify and address factors. Discussion to happen at monthly roundtable meetings.

f. Central Valley Recovery Services –Shirley Cluver: Presentation on what services CVRS provides for our unhoused neighbors. CVRS has five residential treatment facilities with co-occurring services: two men's homes with 45 beds, one woman's home with 16 beds, one prenatal home with 10 beds for women who are pregnant or have children under the age of 2, one women's co-occurring home with 10 beds, as well as outpatient services serving both youth and adults and four sober living homes. CVRS is also offering outreach services in Tulare County. www.cvrshome.com

Eligibility - Dorothy Santana: CVRS operates using Drug Medical and client must meet medical necessity. mAssessment is done to determine if the client is eligible. Screening to determine if client has the correct insurance or is a self-pay. Assessments done at each facility or at the Connections Office.
