 - a. HMIS Update
 - i. Tableau dashboard, over 30 agencies participating in HMIS, almost 90 projects
 - ii. Blue Cross, Libertana, and Shranks Clubhouse are 3 new agencies that have come on board to HMIS.
 - iii. Dashboard is updated each month. They are current up to the last day of the month
 - iv. New CES dashboard that is divided by county on Tableau
 - v. System performance submitted at the end of February
 - vi. PIT data is due at the end of April
 - vii. HMIS committee will start soon, you can email Lucia if you are interested
 - b. CES Update
 - i. https://www.kthomelessalliance.org/coordinated-entry-covid-19
 - ii. From 7/1/201 to 2/28/2022: CES has referred 181 families and has housed 31 families. It takes an average 60 days from referral to housed, to house family.
 - c. KTHA Board of Directors Recruitment
 - i. Looking for law enforcement or someone with a legal background, real estate background, and a person with lived experience to be part of the board. Rebecca Peter from FSTC mentioned in the chat she has a person.

 - i. HHAP 3
- Allocations: KTCoC \$1,592,479.78, Kings County \$349,228.02, Tulare County \$1,137,086.44
- Timeline for KTCoC's HHAP 3 is on the PowerPoint
- ii. CALAIM KTHA has been preliminary approved by Anthem for Navigation Services. KTHA is working with HealthNet to apply for their program. KTHA is hoping to start in the summer of 2022 and collaborate with other CALAIM programs
- iii. ESG
- 2021 ESG Announcements: end of March/beginning of April
- 2022 NOFA will be released in May
- iv. ESG-CV

- Original funding ends 6/30/2022
- Additional funding will be made available by HCD; more information will be available in the coming weeks
- v. City of Tulare Encampment Resolution Funding
 - Application was submitted on December 29, 2021, with partnerships with Kingsview, Salt & Light, and KTHA
 - Award notification was sent on February 28, 2022
 - Funding will be used to improve the health and safety of people living in the identified encampment in the City of Tulare as well as for 12-months of rental assistance
 - Program will start in May 2022
- e. Cal REAL Racial Equity Goal
 - i. 34 California communities were invited to participate in the program (including Tulare County) who are grantees of HHAP funds
 - ii. KTHA and HHSA staff participated in a comprehensive training and developed a community goal to help BIPOC experiencing homelessness to enter into our Coordinated Entry System. KTHA staff took part in weekly trainings with Cal REAL and weekly meetings with HHSA staff to come up with goals.

Goal: By October 2022, engage outreach staff, case managers, service providers, and other participants of the monthly Bi-County Case Management Round Table in 15-20 minute conversations on racial equity, with an initial focus on the tribal community, and report progress to Kings Tulare Homeless Alliance (KTHA) Community Stakeholder Quarterly Meeting and the County-wide Task Force on Homelessness (HTF) at least biannually. By April 2023, we will utilize the feedback of our members to create a forum for broader community engagement around housing racial equity hosting at least 2 events within the next 12 months. This events will be hosted by KTHA during their Membership Meeting and a meeting of the County-wide Task Force on Homelessness.

- iii. Bi County Case Management Roundtable has a racial equity discussion March 17. Case managers discussed racial inequities and disparities within CES. Case managers mentioned:
 - Inability to communicate clearly because of language barriers. Mainly not having enough staff who are Spanish speakers.
 - Clients have mentioned they feel persecuted and left out of getting assistance.
 - People of color have mentioned they are not given the same opportunity as those who are white.
 - Where you live and where you come from affects how quickly you can get services.
